Terms & Conditions for Machynlleth Market
As from 1st April 2012

1. Any stallholder not wishing to operate during the winter period, must pay retainer of ½ rent in advance for 1st January to 31st March to ensure that your pitch is available on your return. Machynlleth Town Council reserves the right to use the pitch for casuals in your absence.
2. Stallholders who operate continuously throughout the winter (1st January – 31st March) will be offered every 4th week at ½ rent during this period.
3. 6 weeks holiday leave per year (1st April – 31st March) is allowed. During the holiday period no rental will be payable. The Market Supervisor must be notified of any holiday period.
4. If a pitch remains un-occupied for a period, of 3 weeks or more than that, pitch may be offered to others and the original stallholder will be then treated as a "casual" on his/her return.
5. The Market Supervisor, in the event of inclement weather, has the authority to offer concessional rates but this is at his sole discretion.
6. The Market Supervisor, in the event of illness of a stallholder, has the authority to offer concessional rates but this is at his sole discretion.
7. The cost of a Regular Pitch will be £1.00 per foot as from 1st April 2012.
8. The cost of a Casual Pitch will be £1.25 per foot as from 1st April 2012.
9. The Market Supervisor is responsible for issuing and allocating all pitches to ensure smooth running and is beneficial to the stallholders and visitors alike.
10. Machynlleth Town Council will liaise with the Market Supervisor for any changes to these Terms & Conditions.
