### Grant Application to replace boilers at the Plas.

An application has been submitted to the National Lottery People and Places fund to replace the boilers at the Plas with newer more efficient and reliable models and to implement other energy saving actions such as fit thermostatic valves to all radiators. The application (minus appendices) is attached for information.

### PROPOSED PROJECT

To replace the outdated boilers at the Plas to better serve the community making it a better warmer space, and through increased efficiency of the boilers keep costs affordable for the community.

### **INTRODUCTION / HISTORY**

Y Plas Machynlleth is a multi-purpose community space and very much the heart of Machynlleth. It was gifted to the town of Machynlleth on 2<sup>nd</sup> December 1948 when the keys were handed over to the Urban District Council. Since then the grounds have become home to Machynlleth Rugby and Football Clubs, Gerddi Bro Ddyfi, Memorial Gardens and Leisure Centre. After 1948 Y Plas itself was used for civic and community purposes as well as providing office space for commercial ventures. In 1995 Montgomeryshire District Council converted Y Plas into The Celtica Visitor Centre. Powys County Council took over Celtica and the house in 1997 when it was formed as a unitary authority in 1997. Celtica closed in March 2006 and the house stood empty while Powys County Council sought to relinquish responsibility for it. At this point, Machynlleth Town Council, realising that the town was in danger of losing the Plas House and grounds, which they saw as belonging to the community in the spirit of the 1948 bequest, consulted the local community and began discussions with Powys County Council with a view to taking over Y Plas. Machynlleth Town Council recognised the importance of preserving Community Facilities and the role that Y Plas House and grounds had in cementing the community bond. In 2007 Machynlleth Town Council provided subsidised community facilities at its Community Centre on Maengwyn street, originally a Drill Hall, with parts of the building dating back to 1910. The building was becoming increasingly unsuitable for most activities it housed with maintenance costs rising year on year. The proposal to the community was that they sold this building and invest the money into the exhibition space left empty by "Celtica" to provide a new community centre that would be affordable and accessible to all. On April 1st 2008 the keys were handed over and Y Plas became a Community Facility for Machynlleth to be proud of.

### SITUATION TODAY

Machynlleth has a population of 2235, it is a small diverse community with a strong community spirit and active local community organisations and events.

The Plas is home to the Food Bank, Gerddi Bro Dyfi, Mach Maethlon, Eco Dyfi, Eginiad, Dyfi Fisheries all of which offer valuable services to the people of the Dyfi Valley, we have worked diligently over the years to support these community groups and provide a home for them.

The space is used by a range of Community Groups for drop-in advice sessions, training, wellbeing, youth groups, home education groups, Counselling services, Give Blood sessions and many other 3<sup>rd</sup>sector organisations.

Y Plas is available for use Monday – Friday 8am – 9pm and 8am – 5pm Saturday and Sundays. We offer free wifi connection. We are accessible.

Y Plas is an advertised Warm Space that can be accessed for free Monday – Friday 8am – 4pm and 10am-3pm Saturday,

Our overall objective is to provide a communal, affordable and inclusive space.

The Plas regularly hosts community groups with the community hall being in use every evening Monday to Friday, those groups alone have over 250 attendees weekly<sup>1</sup>. There is still plenty of

availability for further use of the space<sup>2</sup>. Our community survey has highlighted that warmer, more consistent heating of the building would help us increase the number of users and maximise use of the space<sup>3</sup>.

It is the biggest hall in the area with capacity for up to 250 people. As evidenced by a response to the community survey this is the only venue in Machynlleth that can host large funeral refreshments and thus provides a vital opportunity for the community to come together in a time of grief. Given that these teas are held on average every couple of months, his adds an average of another 125 users per month.

Increased utility costs mean that the increased bookings at the Plas are not resulting in any surplus to carry out necessary repairs and improvements. The increased use, from a wider selection of organisations and community groups, reflects the increased demand on them as a result of the current cost of living crisis.

The boilers at Y Plas are obsolete and inefficient which means running costs, therefore costs to the community are higher than they might otherwise be. Similarly, we are unable to provide the consistently warm spaces requested in our community survey. We have been told by the company who service our boilers that they could now fail at any time<sup>4</sup>.

In addition to an increase in utility bills we are facing a £5000 increase in business rates payable to Powys County Council in April. We are facing a set of challenges on an unprecedented scale. We are still recovering from the Covid -19 pandemic where we had severe losses due to the building being closed down. We worked hard throughout adapting and changing the way we worked within the guidelines. We became the venue for the mobile drive through testing unit working alongside Powys Teaching Health Board, this was a vital service provided in the most difficult of times.

### **OPTIONS APPRAISAL**

An energy survey<sup>5</sup> was conducted at the Plas in November 2019 and reported in January 2020 presenting a range of no cost, low and high capital cost recommendations.

The no and low capital cost improvements recommended have been implemented. Intermediate projects such as fitting secondary glazing are being investigated but the listed status of the building creates some obstacles to completing that work.

This report identified that a newer condensing boiler unit would likely increase the overall efficiency of the heating system by 10-15%, the situation is now more acute with one of the four boilers not working at all and having received quotes to replace the boiler, the engineers providing the quotes believe a new boiler will increase efficiency by 23-30%. Given that we spent around £20,000 on gas to heat the Plas last year this represents a significant lessening of costs which might otherwise have to be passed on to the end user - community groups.

The boilers here at Y Plas are beyond their economic life, they are inefficient and need replacing in order to reduce running costs and carbon emissions. We have spent £4977.60 so far this year on repairs and the most recent service has highlighted a further repair of boiler 2 with an estimated cost of £1000.

Four separate quotes were sourced against the specification suggested by our heating engineer and they are attached. The cheapest of these came in at £38,900+VAT. Further works will be required to properly commission the control system £1100+VAT and fit thermostatic valves to all 105 radiators£14,400+VAT. We also investigated the possibility of a ground source heat pump, to further lower our carbon emissions<sup>6</sup>. We have decided to go with a traditional boiler on grounds of cost<sup>7</sup> as well as the fact that the heat pump would likely be less effective given the age of the building and would still require a new boiler to be fitted to provide heat on cold days. A further benefit of the cheapest boiler quote is that it was provided by a local company (spending locally provides additional benefit to the community) with whom we already have a relationship and in whom we have confidence.

The report further identified that fitting photon voltaic solar panels would both reduce costs and improve the carbon footprint with regards to electric supply. Windfall the Mid Wales Community Energy Trust and Bro Ddyfi Community Renewables have both suggested they might provide grants towards the cost of installation. A business case for the improvement is currently been worked out and a solar panels project will provide added value to the investment in new boilers.

### **TIME SCALES**

If the funding is secured, we would aim to complete the works in Summer 2023 to ensure minimum disruption to the community groups and individuals who use the Plas.

### HOW OUR PROJECT ADDRESSES THE PROGRAMME PRIORITIES

We support people, communities and organisations that are facing increased demands and challenges as a direct result of the cost of living crisis by:

- We provide a regular meeting room to POBL who provide cost of living support and advice and are seeing increased demands on their services as a direct result of the current crisis.
- Mums matter meet in our Vane Tempest room. This group provides advice and support to
  new mums and a free creche facility whilst the mothers access the service. Their response to
  our community survey highlighted that increasing demands mean they would like to utilise
  the larger space provided by the Hall but that the current heating system does not allow the
  space to be effectively heated to the temperature they require.

The Plas supports people, communities and organisations with the direct and indirect impact of the cost-of-living crisis by:

- Offering premises to the food bank at a peppercorn rent. This has resulted in the distribution of over 200 food parcels in the last 12 months.
- Giving premises to Gerddi Bro Ddyfi at a peppercorn rent allowing them to provide a
  therapeutic community wildlife garden for all people in the Bro Ddyfi area. They offer
  inclusive gardening drop-in sessions and free public workshops. These provides some respite
  for those at risk of social exclusion and opportunities for the community to come together at
  no financial cost to members of the community.
- providing a base for Mach Maethlon who grow food in public spaces around the town which is available to the public free of charge.

- We provide a space for groups that help with weight loss thus improving physical and mental wellbeing and promoting healthy eating on a budget.
- By keeping hire costs down, we help youth and community groups such as the scouts, a
  karate class and a stage school to provide affordable quality of life improving activities for
  young people in Machynlleth.
- Likewise, a dyslexic support service utilises rooms at the Plas and will face increasing costs if we are unable to mitigate rising utility costs.

The Plas and the Town Council are experiencing current cash flow problems resulting from losses or short term liquidity challenges as a direct result of rising utility costs and the broader inflationary pressures that have combined to create the cost of living crisis. The only options to continue providing the community support outlined in this application would be to increase charges to end users or to again increase the precept – both of which would only further increase cost of living pressures on residents of Machynlleth and the Dyfi Valley.

### **IMPACT STATEMENT**

Through consulting our current users, they have told us that without Y Plas they could NOT run their classes as there is not a venue of similar size and access within the area. Replacing the outdated boiler will provide an improved facility for users. The aim is to ensure that the building can continue to be a focal point for community facilities including space for education wellbeing and community classes rental space for community groups as well as a facility for entertainment and conferences

### **GAP ANALYSIS**

If the boilers were to fail then the Plas would likely be forced to close as a community facility. The 259 weekly users identified in our user survey along with the extra 125 monthly users who attend occasional events such as funeral teas have already stated that there is no other suitable venue in the town. This is because no other venue can host such large groups and no other venue is open as late as the Plas.

This would effect the physical and mental wellbeing of those who access support through the Plas or who attend social events and community groups. Further consequences are outlined in the attached mind map.

The Welsh Blood service would also have no base for the 576 quarterly appointments it currently provides from the Plas to collect blood donations.

### **CURRENT FINANCIAL SITUATION**

Audit Wales expects Town and Community Councils to hold between 3 and 12 months of expenditure as a general reserve. Machynlleth Town Council had £97,529 in general reserves in April 2022, total spending for the financial year 2021-22 was £325,121 and at this level of spending the Council would be expected to hold a minimum of £108,374 in reserves. We now hold £107,956 in bank accounts, £17,850 of which is in an earmarked fund leaving only £90,106 in general reserves. It would therefore not be permissible for the Council to fund the boiler replacement out of reserves.

Increasing the precept to fund the boiler replacement is the only other option for the Council, however given that we have had to increase the precept by 43.6% for 2023-24 purely to fund already identified liabilities and cost increases, this option is theoretical rather than practical and would likely increase cost of living pressures on residents of Machynlleth.





### 1. What is palm oil?

It's an edible vegetable oil that comes from the fruit of oil palm trees, the scientific name is Elaeis guineensis. Two types of oil can be produced; crude palm oil comes from squeezing the fleshy fruit, and palm kernel oil which comes from crushing the kernel, or the stone in the middle of the fruit. Oil palm trees are native to Africa but were brought to South-East Asia just over 100 years ago as an ornamental tree crop. Now, Indonesia and Malaysia make up over 85% of global supply but there are 42 other countries that also produce palm oil.

### 2. What products is it in?

Palm oil is in nearly everything – it's in close to 50% of the packaged products we find in supermarkets, everything from pizza, doughnuts and chocolate, to deodorant, shampoo, toothpaste and lipstick. It's also used in animal feed and as a biofuel in many parts of the world (not in the UK though!).

### 3. Why is palm oil everywhere?

Palm oil is an extremely versatile oil that has many different properties and functions that makes it so useful and so widely used. It is semi-solid at room temperature so can keep spreads spreadable; it is resistant to oxidation so can give products a longer shelf-life; it's stable at high temperatures so helps to give fried products a crispy and crunchy texture; and it's also odourless and colourless so doesn't alter the look or smell of food products. In Asian and African countries, palm oil is used widely as a cooking oil, just like we might use sunflower or olive oil here in the UK.

As well as being versatile, compared to other vegetable oils the oil palm is a very efficient crop, able to produce high quantities of oil over small areas of land, almost all year round. This makes it an attractive crop for growers and smallholders, who can rely on the steady income that palm oil provides.

### 4. What is the problem with palm oil?

Palm oil has been and continues to be a major driver of deforestation of some of the world's most biodiverse forests, destroying the habitat of already endangered species like the Orangutan, pygmy elephant and Sumatran rhino. This forest loss coupled with conversion of carbon rich peat soils are throwing out millions of tonnes of greenhouse gases into the atmosphere and contributing to climate change. There also remains some exploitation of workers and child labour. These are serious issues that the whole palm oil sector needs to step up to address because it doesn't have to be this way.

### 5. What solutions are there?

Palm oil can be produced more sustainably and there is a role for companies, governments, and consumers to play. The Roundtable on Sustainable Palm Oil or RSPO was formed in 2004 in response to increasing concerns about the impacts palm oil was having on the environment and on society. The RSPO has production standards for growers that set best practices for producing and sourcing palm oil, and it has the buy-in of most of the global industry. RSPO encourage companies to:

- Set robust policies to remove deforestation, conversion of other natural ecosystems, such as peatlands, and human rights abuses from their supply chains
- · Buy and use RSPO certified palm oil across their operations globally
- Be transparent in their use and sourcing of palm oil ensuring they know who they are buying from and where it's been produced

It is important that the palm oil industry continues to invest in and grow support for smallholder programmes and sustainable landscape initiatives. WWF is also working with governments in both palm oil using and palm oil producing countries to make sure that national laws are in place to ensure that any palm oil traded is free of deforestation, conversion and exploitation.

### 6. Why don't we just switch to an alternative vegetable oil?

Palm oil is an incredibly efficient crop, producing more oil per land area than any other equivalent vegetable oil crop. Globally, palm oil supplies 40% of the world's vegetable oil demand on just under 6% of the land used to produce all vegetable oils. To get the same amount of alternative oils like soybean, coconut, or sunflower oil you would need anything between 4 and 10 times more land, which would just shift the

problem to other parts of the world and threaten other habitats, species and communities. Furthermore, there are millions of smallholder farmers who depend on producing palm oil for their livelihoods. Boycotting palm oil is not the answer. Instead, we need to demand more action to tackle the issues and go further and faster.

### 7. Can I trust RSPO certified products?

The RSPO is the global standard for the sustainable production of palm oil. When palm oil is produced in adherence to RSPO standards, growers help to protect the environment and the local communities who depend on the crop for their livelihoods, so that palm oil can continue to play a key role in food security, economic development, and food supply chains. We should continue to use RSPO certified sustainable palm oil in products, as replacing it would result in more deforestation and natural habitat conversion. RSPO certified products that use palm oil from 'Segregated' or 'Identity Preserved' supply chains offer the greatest assurance of sustainable palm oil.

Along with other organisations, WWF plays an active role in influencing and shaping the RSPO standard to make sure it puts in place more safeguards for people and the planet. In November 2018, the RSPO standard was strengthened and it now represents an essential tool that can help companies achieve their commitments to palm oil that is free of deforestation, conversion of other natural habitats like peatlands, and the exploitation of people.

### 8. What is being done in the UK?


In 2012, the UK Government recognised that we were part of the palm oil problem and could also be part of the solution. They set a commitment for 100% of the palm oil used in the UK to be from sustainable sources that don't harm nature or people. In 2019, 70% of the total palm oil imports to the UK were sustainable. This is great progress but there is more to be done to get to 100%.

An area that represents a substantial gap in the uptake of certified sustainable palm the use of palm-derived ingredients in animal feed – for chickens, pigs and cows, for example. Much of this palm oil material is unlikely to be certified. This area requires much stronger transparency and ambition from the UK industry, and is going to be critical over the coming years if we are to truly tackle the UK's palm oil footprint.

### What can I do?

The best thing we can do is support sustainable palm oil and avoid boycotts, since we know substitutions with other vegetable oils can lead to even further environmental and social harm.

The Welsh Government said tackling deforestation was "vital".

A report, complied by WWF Cymru, RSPB Cymru and Size of Wales, calls for action to limit the amount of goods being imported into Wales linked to deforestation.

The campaigners want the next Welsh Government to make changes to public procurement rules, to stop school and hospital canteens serving up dishes containing certain products.

The report warns there are risks of sparking further pandemics, as wild animals are forced into closer contact with humans and livestock due to deforestation.

Barbara Davies Quy, of Size of Wales, said a forest the size of a rugby pitch was being lost every two seconds in a bid to produce products such as palm oil, soy, timber, coffee, cocao and beef.

"All of these products are imported into Wales and may end up in the food and drink we consume every day," she said.

"We're all part of a deforestation economy."

### So how could it happen?

The campaigners want to see Welsh ministers urge the UK government to push ahead with plans <u>in its new environment bill</u> to ban firms from selling certain goods in the UK if they have been grown on land that breaches local laws on protecting forests

In the report, put forward ahead of this year's Senedd election, the charities also call for the Welsh Government to go a step further to become a world leader in tackling climate change.

The report calls on ministers not to give grants to businesses unless they commit to using deforestation-free supply chains, and for a new local and sustainable food strategy to be introduced, with farmers incentivised to move away from using imported soy to feed their livestock.

Rhys Evans, of RSPB Cymru, said people might not realise that over 80% of the soy sent to the UK was used for animal feed.

He said the Welsh Government had any opportunity to support ways of working that "reduce reliance on external inputs" during its review of farming subsidies post-Brexit.

"We [also] need a food system that both drives and rewards local, sustainable farm to fork supply chains and prioritises only sustainable goods from overseas to support livelihoods at home and abroad," he said.




